

OFFICIAL RULES OF THE DOLLAR DRIVE FOR A CHANCE TO WIN SWEEPTAKES

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE OR PAYMENT OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING.

Eligibility: The Dollar Drive For a chance to Win Sweepstakes ("Promotion") is open only to natural persons who are legal residents of the United States of America who have a valid social security or tax ID number and who are at least twenty-one (21) years of age at the time of entry. Promotion may only be entered from and in eligible jurisdictions. Promotion Entities, prize providers, and their respective parent, subsidiary and affiliate companies, employees, agents, and suppliers, as well as the immediate family (spouse, parents, siblings, and children) and household members of each such employee are not eligible to participate. Once the postcard is received by Sponsor, Entrant will receive one (1) Entry into the Promotion. Promotion Entities are not liable for mail delivery failure due to inaccurate, illegible or incomplete submissions. Limit: one (1) entry per mail-in request. Ten (10) maximum Entries per Entrant via mail-in entries.

Administrator reserves the right to cancel, suspend and/or modify the Promotion, or any part of it, if any fraud, technical failures or any other factor beyond Promotion Entities' reasonable control impairs the integrity or proper functioning of the Promotion, as determined by Administrator in its sole discretion. In such event, Administrator reserves the right to award the prizes at random from among the eligible entries received up to the time of the impairment. Administrator reserves the right, in its sole discretion, to disqualify any individual it suspects or finds to be tampering with the entry process or the operation of the Promotion or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner.
